#### RECENT ECONOMIC DEVELOPMENTS AND PROSPECTS

In this talk, I will review recent economic developments in Australia and globally. Australia is a small open economy and economic developments in Australia's major trading partners will affect GDP growth, inflation, the growth of real wages, and employment in Australia. I will argue that most of the build-up in inflation was due to a combination of ultra-loose monetary policy, tight labor markets, and supply-side shortages. As supply-side shortages are resolved this will ease inflationary pressures. Nominal interest rates have risen in advanced economies and it is quite likely that this will significantly contribute to a reduction in demand, and thus inflation.
