

# THE NEW SPACE AGE: NASA, SPACEX, AND THE FUTURE OF AUTONOMOUS CRAFT - PERSPECTIVES FROM A FUTURIST

There is a universal uncertainty in the approach to change in leveraging AI and Augmented/Virtual Reality into the workplace. NASA itself is having to overcome a change bias built into their culture from the 1990s, in that the tech they have used for decades works and is relatively bullet proof in withstanding the realities of radiation in space for long periods of time.

NASA is having to upend an approach from tried and true supervised learning craft relying on windows of communication with scientists back on Earth, to unsupervised learning craft built with Al driven Alalgorithmic programming on board to make decisions on it's own. In this session, we explore this culture shift, and how it is a model that can be applied to professional services and the legal industry across the globe as Al integration becomes a reality, and we evolve towards the augmented and virtual reality workplaces of the future.
